## Summary

# II. Programming: 2008 NALP Annual Conference

The GLBT Section will present two programs at the 2008 NALP Annual Conference.

A. Solomon Amendment: Continuing the dialogue in light of amended regulations, enhanced amelioration initiatives, and support of LGBT rights outside of the military. Presenters – Carlos Dávila-Caballero, Tulane University Law School, Angie Dalfen, Golden Gate University Law School, and Gary Greener, Southwestern University Law School.

B. Strengthening LGBT Recruiting at Law Firms: Developing partnerships between law schools and legal employers to increase law LGBT recruitment in the profession. Presenter Eric Stern, University of California, Berkeley School of Law.

The members of the Section discussed whether the name of the Section reflected current practices within the GLBT community as well as legal professional organizations. Over the years, the acronym GLBT has evolved to LGBT and most recently to other names, including ABA's recent announcement in forming a Commission on Sexual Orientation and Gender Identity. The members discussed at length whether NALP members would support similar new variants, improve internal/external communication of the Section, create confusion among some members –including private firms/affinity groups-, and a series of other considerations. Most members suggested further monitoring of these developments and to revisit the issue if a general consensus is reflected by the legal industry. The Section will maintain the Board appraised of future discussions.
