Mini-Conference Planning

Work Group members had a conference call on Tuesday, May 27.

The Mini-Conference is an annual event that takes place during the same weekend as the Equal Justice Works Conference and Career Fair. This year's Mini-Conference is scheduled for Saturday, October 11, 2008, from 9:00 a.m. – 3:00 p.m. at the Georgetown University Law Center. Traditionally, the Mini-Conference is held on a day preceding the Career Fair. But this year, the Career Fair (Friday, October 10 and Saturday, October 11) is bookended by a religious and a federal holiday. In order to help members maximize on the time spent in D.C. and travel conveniently, the Mini-Conference will take place on Saturday, October 11. The Mini-Conference will begin at 9:00 a.m. with a welcome and continental breakfast, followed at 9:30 by a Public Service Section meeting. At 11:00 we'll have a demonstration of the new PSLawNet site, followed at noon by lunch and the *Pro Bono Publico* Award Ceremony. Three concurrent breakout sessions will run from 1:30 – 3:00: Counseling on Public Service Salary Issues, New Administration = New Federal Jobs, and a Pro Bono-related session that is still being fleshed out.

Also that weekend, NALP and Equal Justice Works will host a networking reception for Law School career services folks and Career Fair employers. The reception will take place at the close of the interview period on Friday, October 10 at the Omni.

Just prior to the above reception, NALP will again host a "Get to Know You/ Nuts & Bolts" event for law school public interest advising newcomers. This will include a substantive overview of issues new counselors face and an introduction to the resources available to them.

Work Group goals include: 1) providing information that will raise interest in federal government opportunities, 2) highlighting what types of opportunities are available (practice areas and locations), 3) explaining where and how to find these jobs (for current students and laterals, and including both specifically legal and non-traditional jobs for lawyers), and 4) clarifying how to get these jobs (i.e., providing sample KSAs, federal resumes, etc.). Private-to-Public Interest Pipeline
