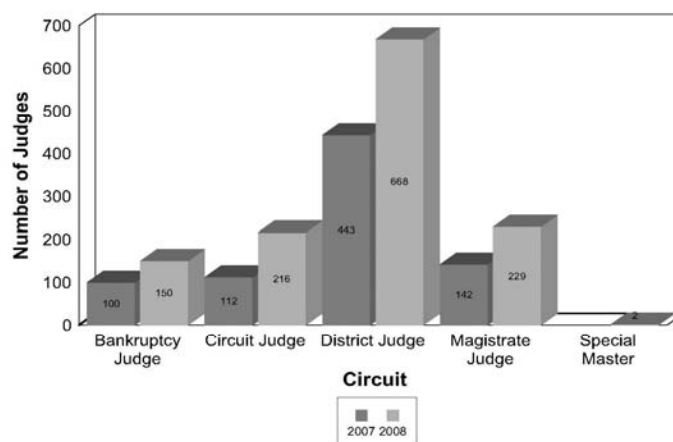

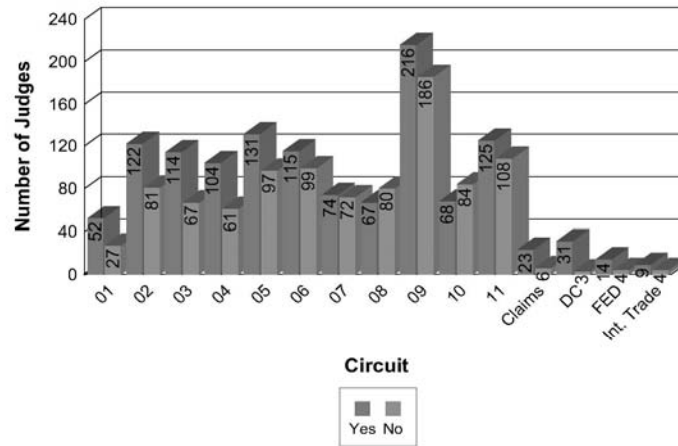

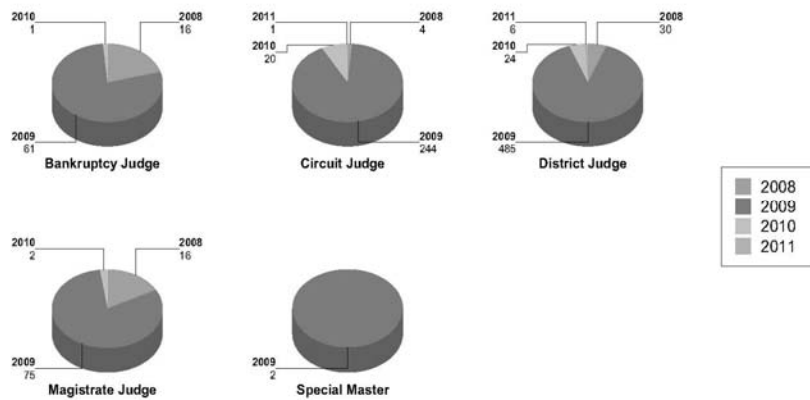
Participating Judges by Judge Type and Year

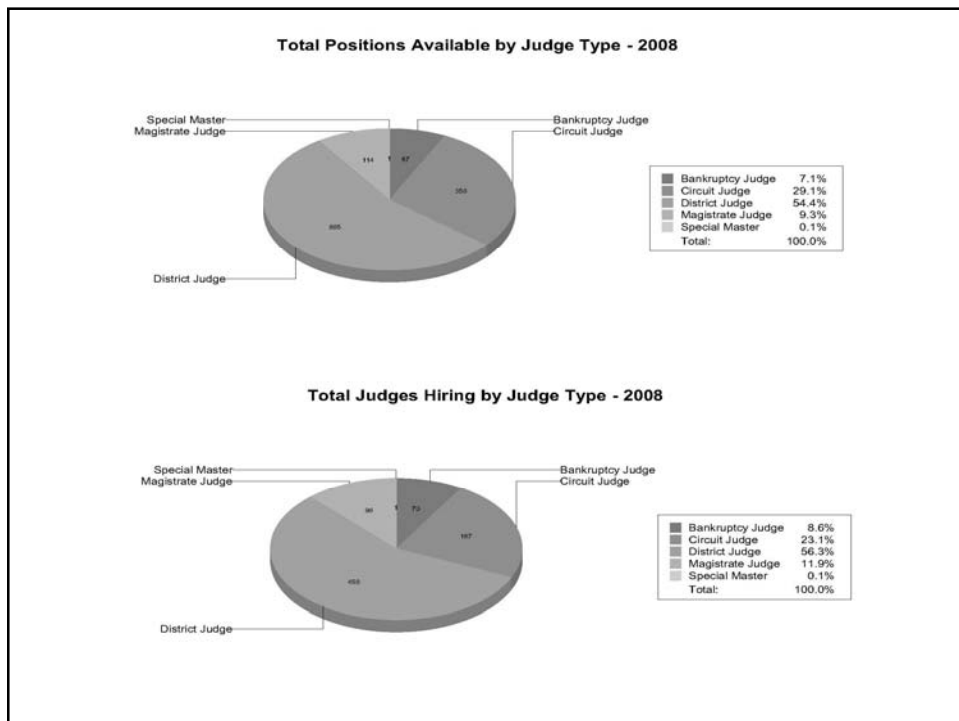
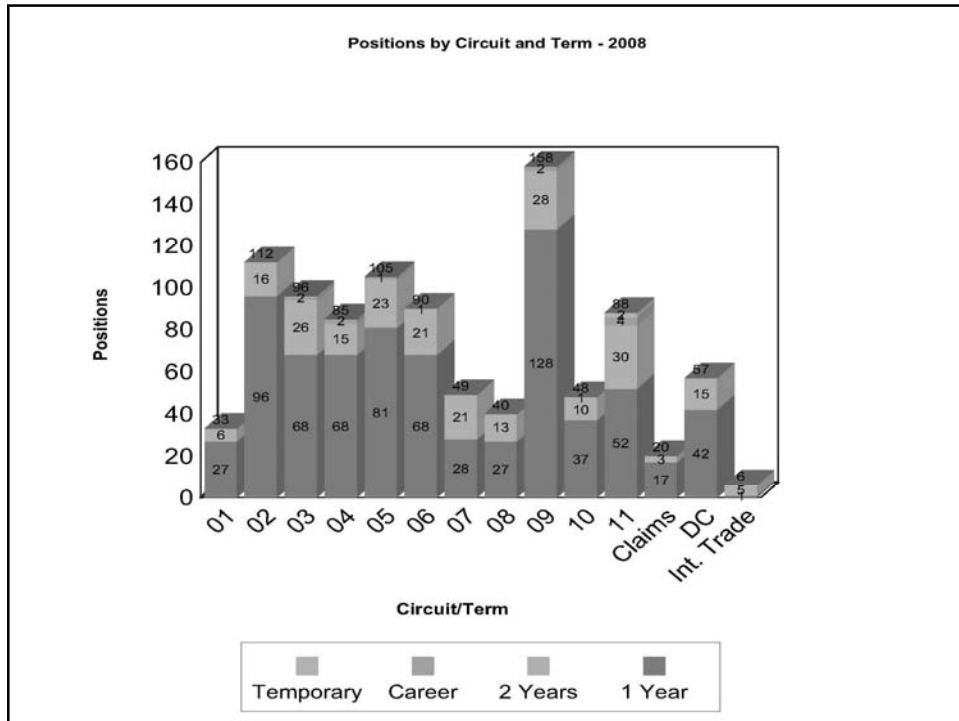


Participating Judges by Circuit - 2008



Positions by Judge Type and Term Start Date - 2008

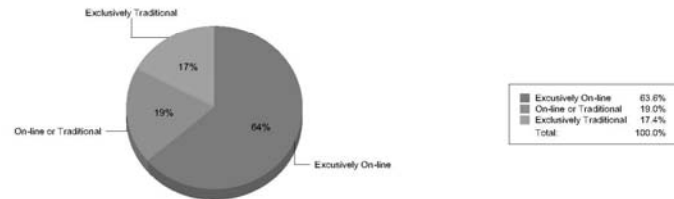




Application Methods - By Judge - 2008

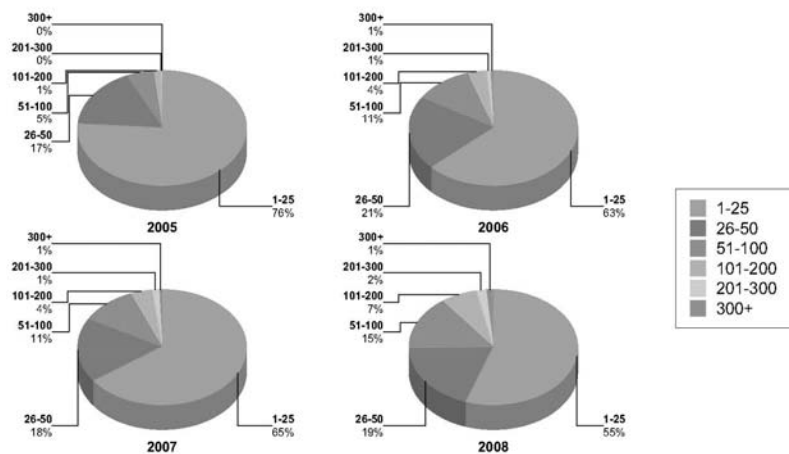

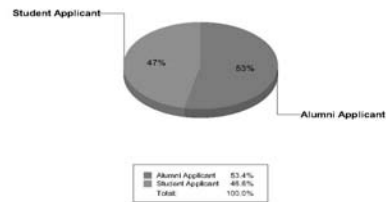
Traditional Application Methods Include Paper, E-mail, and Fax

Percentage of Applicants by Application Range

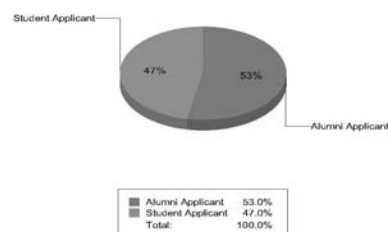


Range 1-25, 26-50, 51-100, 101-200, 201-300, 300+

OSCAR PUBLIC SITE

- New URL: <https://oscar.uscourts.gov>
- Only “Participating” OSCAR Judges Listed
 - “Participating” judge has established an OSCAR account and entered profile information



SECURE OSCAR SITE

- All judges are listed
 - Nonparticipating judges are grayed out
 - Participating judges are listed with any clerkship positions below their names
 - New column: “last update” date
 - Judge’s last name will be the link to additional information
 - No separate link from the list to each clerkship
 - New Resources Tab: User Guides, blogs, videos



PARTICIPATING JUDGE INFORMATION DISPLAY

- Judge Details Tab
 - Basic judge information: name, type of judge, name of court, chambers city
 - New section of chambers information: number of clerks (career, term, temporary) and other chambers staff, plus contact preferences



CLERKSHIPS TAB

- If a judge has posted positions, a Clerkships tab will display, and clicking on that tab will take users to a list of the judge's clerkships
- Users click on a specific clerkship to see the full details about a clerkship and to build an application online.



NEW FOR APPLICANTS

- Changes to Search Options
 - Clerkship Position Status checkboxes
 - Available
 - Filled
 - Expired
 - None
 - Search by term start month/year
 - Specific search for most recent changes



NEW FOR APPLICANTS

- My Profile modifications
- Streamlined grade sheet
- Simplified online application steps
- Enhancements to Applications Tab and Batch Options



NEW FOR RECOMMENDERS

- Email modifications
 - Recommender name in the Evite subject line and applicant name(s) in the body
 - Recommenders can now receive email notices and reminders daily
- Clearer steps in electronic letter submission



NEW FOR LAW SCHOOL ADMINISTRATORS

- “Law School Profile” tool to link to NDLS page
- Revisions to the Master Directory of Recommenders to curtail duplication
- Enhanced recommender email management
- Judge and Application information now displayed on Applicant interface will be accessible in the LSA interface
