

## Special Report to Survey Participants

Thank you for submitting data to NALP's 2025 U.S. Associate Salary Survey! Several National Summary Tables are being provided to you in appreciation for your participation in the survey:

- Median base salaries by associate year and firm size;
- The range of average base salaries by associate year and firm size;
- Median base salaries for intellectual property lawyers by associate year and firm size; and
- Median salaries for law clerks by firm size.

Median base salaries are reported in several tables of this report. The median salary is the middle value (50th percentile) in a list of salaries ranked from high to low, or the point at which half the salaries are at or above that value and half are at or below it. The median therefore provides a summary measure that is not affected by extremely low or extremely high values. However, if the reported salaries cluster at certain amounts, such as \$225,000, the median may not fall at a single salary, but rather in a cluster of identical salaries. The median salary might even be the most commonly reported, or prevailing salary.


